

## **V100's 1 Second, 1 Song, Up to \$1000 dollars**

Selection of V100 (WVAF) “1 Second, 1 Song, Up to \$1000 dollars” contest players is by random selection from all contest entries submitted.

Weekday mornings, except holidays and any other undetermined day, at approximately 7:20, 8:20 and 9:20 AM, Steve and Jenny will play the “1 Second, 1 Song, Up to \$1000 dollars” contest. A random contestant will be selected prior to each game time to play and contacted by the telephone number submitted on their entry.

A one second audio “snippet” of a song will be played on V100. The contestant will be given one guess to identify the correct title and artist of the song. If the title and artist is correctly identified, the contestant will win the current cash jackpot amount. Jackpot amount begins at \$100.00, increasing \$25.00 for each incorrect guess, up to a maximum of \$1000.00
